

SOP/POLICY ON RELATED PARTY TRANSACTIONS W.E.F. 01.04.2024

Approved by Board of Directors at its meeting held on 26.03.2024, on the recommendation of Audit Committee.

<p><u>Preamble</u></p>	<p>The Board of Directors of the Company ("Board"), acting upon the recommendation of its Audit Committee of Directors ("Committee"), has approved the following policy and procedures with regard to Related Party Transactions for reviewing, approving and ratifying Related Party transactions and in providing disclosures with respect to the above transactions, as required under the Companies Act, 2013, SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations, 2015") as amended from time to time and other applicable provisions, rules and regulations made there under.</p> <p>The Board has approved the policy for Related Party Transactions (in compliance with the requirements of the Companies Act, 2013 ("Act") and Rules made thereunder, in terms of Indian Accounting Standard - 24 ("Ind-AS 24") issued by the ICAI (Institute of Chartered Accountants of India) and any subsequent amendments thereto), in terms of Regulation 23 of Listing Regulations, 2015, RBI guidelines and other applicable SEBI Regulations etc., undertaken by the Company in order to ensure the transparency and substantive and procedural fairness of such transactions.</p>
<p><u>Applicability</u></p>	<p>This policy shall come into force with effect from 01.04.2023 and shall be applicable to transactions made with:-</p> <ul style="list-style-type: none">(a) Board of Directors & their Relatives;(b) Key Managerial Personnel (KMP) of the Company & their Relatives; and(c) Related Parties, as defined hereinafter.

Declaration regarding a public company in which a Director or manager is a Director and holds along with the relatives more than 2% of the paid-up share capital. 6. <p><u>Type of Transactions covered</u></p>	<p>a) Under Section 188 of the Act, following transactions will be covered -</p> <ol style="list-style-type: none"> 1. <p>Process for ascertaining related party</p>	<p>Secretarial Department to prepare the list of Related Parties on the basis of aforesaid information. Concurrent auditors to verify the process of ascertaining the Related Parties and their correct recording /listing in register of Contracts/arrangement etc. as per the Section 189 of the Act and Rules thereof as well as classification of related party transactions regarding whether they are in ordinary</p> <p>b) course of business and on at arm’s length basis.</p>
<p>Circulating of above list of related parties</p>	<p>The aforesaid list shall be circulated to MD /CEO’s/ COO’s/ED/Dy. CEO/CFO/Business Heads/ Department Heads/ Branch Heads, the Finance & Accounts Department and Concurrent Auditor.</p>
<p>Procedure of seeking approval</p>	<p>Functional departmental heads shall submit to the CFO and Company Secretary the details of proposed transaction with details/draft contract/ draft agreement or other supporting documents justifying that the transactions are on arms’ length basis in an ordinary course of business at prevailing market rate. Based on this note, CFO and Company Secretary will appropriately take it up for necessary prior approvals from the Audit Committee at its next meeting and convey back the decision to the originator.</p>

	<p>The suggested list of records and supporting documents is detailed separately in this policy.</p> <p>If the proposed transaction is not in ordinary course of business but at arms' length basis, then the Functional departmental heads shall give a detailed note with justification to Dy. CEO, CFO and CS for entering such transaction alongwith details of proposed transaction with draft agreement/ MoU/other supporting documents. Based on this note, the Dy. CEO, CFO and CS will discuss the matter with MD so as to escalate the matter further with Audit Committee, Board and then to shareholders for their respective prior approvals.</p>
<p><u>Approval of transactions</u></p> <p>(A) <u>Approval of transactions through Audit Committee</u></p>	<p>Prior approval of Audit Committee for all Related Party Transactions and all subsequent material modifications.</p> <p>Material Modifications shall mean change/modification in the aggregate value of transaction approved by the Audit Committee/Board/shareholders, as the case may be, for an amount exceeding 20% but not exceeding Rs. 1000 crore-</p> <p>Provided that Audit Committee may while granting approval to any related party transaction, outline the specific criteria for determining material modification for the said transaction.</p> <p>Further, the Audit Committee may also grant an omnibus approval for a period of maximum one year for those proposed related party transactions, which are in ordinary course of business and at arms' length and are repetitive in nature (for e.g. sale/purchase of securities etc), subject to the following conditions -</p> <p>The proposal to be placed before the Audit Committee should contain following information -</p> <ol style="list-style-type: none"> a) The name(s) of related party, nature of transactions, period/duration of transactions, maximum amount of per transaction that can be entered into and maximum value of the transactions in aggregate which can be allowed under the omnibus route in a financial year; b) The indicative base price/current contracted price and the formula for variation in the price, if any; and c) any other information relevant or important for the Audit Committee to take a decision on the proposed transaction. <p>Provided that where the need for related party transaction cannot be foreseen and aforesaid details are not available, audit committee may make omnibus approval for such transactions</p>

subject to their value not exceeding rupees one crore per transaction.

Omnibus approval shall not be made for transactions in respect of selling or disposing of the undertaking of the company.

Omnibus approval shall be valid for a period not exceeding one financial year and shall require fresh approval after the expiry of such financial year.

All transactions entered into above omnibus approval, be put up to the Audit Committee on quarterly basis for its review. All the related party transactions entered under omnibus route be certified by the Concurrent Auditors on quarterly basis.

In case of non-repetitive transactions, the agenda of the Audit Committee at which the item is proposed to be moved shall disclose-

- a) the name of the related party and nature of relationship;
- b) the nature, duration/period of the contract and particulars of the contract or arrangement;
- c) the material terms of the contract or arrangement including the value, if any;
- d) any advance paid or received for the contract or arrangement, if any;
- e) the manner of determining the pricing and other commercial terms, both included as part of contract and not considered as part of the contract;
- f) whether all factors relevant to the contract have been considered, if not, the details of factors not considered with the rationale for not considering those factors;
- g) any other information relevant or important for the Audit Committee to take a decision on the proposed transaction; and
- h) statement of transactions as per the contracts/arrangements.

Where any director is interested in any contract or arrangement with a related party, such director shall not be present at the meeting during discussions on the subject matter of the resolution relating to such contract or arrangement. The MD, Dy. CEO and CFO should certify whether the contracts/transactions are at arm's length. Similarly the concurrent auditors should examine the entire documentation and certify the same.

(B) Approval of transactions through Board of Directors

Approval of the Board is required:

1. for all contracts/arrangements/transactions which are not

<p><u>(C) Approval of transactions through shareholders</u></p>	<p>on arm's length basis or are not in ordinary course of business;</p> <p>2. For all "material" related party transactions. These have to be approved by the shareholders through Ordinary Resolution; therefore they should first be approved by the Board.</p> <p>The agenda of the Board meeting at which the resolution is proposed to be moved shall disclose-</p> <ul style="list-style-type: none"> (a) the name of the related party and nature of relationship; (b) the nature, duration of the contract and particulars of the contract or arrangement; (c) the material terms of the contract or arrangement including the value, if any; (d) any advance paid or received for the contract or arrangement, if any; (e) the manner of determining the pricing and other commercial terms, both included as part of contract and not considered as part of the contract; (f) whether all factors relevant to the contract have been considered, if not, the details of factors not considered with the rationale for not considering those factors; and (g) any other information relevant or important for the Board to take a decision on the proposed transaction. (h) Statement of transactions as per the contracts/ arrangements. <p>Where any director is interested in any contract or arrangement with a related party, such director should not be present at the meeting during discussions on the agenda item relating to such contract or arrangement.</p> <p>Except with prior approval of shareholders, the Company shall not enter into transaction(s), where the transaction(s) to be entered into as contracts or arrangements with respect to Section 188(1)(a) to (e) of the Act, with the criteria as mentioned below -</p> <ul style="list-style-type: none"> i. sale, purchase or supply of any goods or materials, directly or through appointment of agent, amounting to ten per cent or more of the turnover of the company, as mentioned in clause (a) and clause (e) respectively of sub-section (1) of section 188; ii. selling or otherwise disposing of or buying property of any kind, directly or through appointment of agent, amounting to ten per cent or more of the turnover of the company, as mentioned in clause (b) and clause (e) respectively of

- sub-section (1) of section 188;
- iii. leasing of property of any kind amounting to ten per cent or more of the turnover of the company, as mentioned in clause (c) of sub-section (1) of section 188;
 - iv. availing or rendering of any services, directly or through appointment of agent, amounting to ten per cent or more of the turnover of the company, as mentioned in clause (d) and clause (e) respectively of sub- section (1) of section 188:

Explanation. – It is hereby clarified that the limits specified in sub-clauses (i) to (iv) shall apply for transaction(s) to be entered into either individually or taken together with the previous transactions during a financial year.

(b) is for appointment to any office or place of profit in the company, its subsidiary company or associate company at a monthly remuneration exceeding two and half lakh rupees as mentioned in clause (f) of sub- section (1) of section 188; or

is for remuneration for underwriting the subscription of any securities or derivatives thereof, of the company exceeding one per cent of the net worth as mentioned in clause (g) of sub-section (1) of section 188.

Explanation.- The Turnover or Net Worth referred in the above sub-rules shall be computed on the basis of the Audited Financial Statement of the preceding Financial year.

The explanatory statement to be annexed to the notice of a general meeting convened pursuant to section 101 shall contain the following particulars namely:-

- (a) name of the related party ;
- (b) name of the director or key managerial personnel who is related, if any;
- (c) nature of relationship;
- (d) nature, material terms, monetary value and particulars of the contract or arrangement;
- (e) any other information relevant or important for the members to take a decision on the proposed resolution.

Apart from the above, even related party transactions that are in the ordinary course of business and at arm's length would require shareholders' prior approval by way of an ordinary resolution if they are 'material' within the meaning of Regulation 23 of Listing Regulations, 2015. All subsequent material modifications to such transaction(s) as defined in this policy shall also require prior approval of shareholders. Thus,

	<p>Mid Office will keep track of all the related party transactions and monitor the exercise of limits approved by the Audit Committee, Board and shareholders, on regular basis. Mid Office shall report to MD & CEO with information to CFO and CS so that the CFO and CS can take required shareholder approval well in advance so as to ensure compliance of Regulation 23 of Listing Regulations, 2015 on material related party transactions. concurrent auditor shall also ascertain if shareholder approval is required under the Act and /or Regulation 23 of Listing Regulations, 2015 and report to Audit Committee on monthly basis.</p> <p>Note:</p> <ol style="list-style-type: none"> 1. Only those members of Audit Committee who are independent directors shall approve related party transactions in the Audit Committee Meeting. 2. Any director who is concerned or interested in any contracts/ transactions with a related party, such Director shall not be present at the Audit Committee / Board Meeting during discussion on the subject matter of the resolution relating to such contract/transactions and shall not be entitled to vote for such item in General Meeting if he is a shareholder of the Company. 3. <p><u>Related party transactions details</u></p>	<p>The Finance & Accounts Department shall provide a list of transactions with Related Party on a monthly basis to the Secretarial Department and concurrent Auditor within 7 days of close of each month and the same shall be reviewed by the concurrent/statutory auditors along with Quarter end balance confirmation/ reconciliation statements and placed before the Audit Committee.</p>
<p>Threshold Limit under Regulation 23 of Listing Regulations, 2015</p>	<p>The Related Party Transactions per related party during a financial year shall not exceed 10 %of the consolidated turnover of the Company during the last financial year.</p> <p>However, a transaction involving payments made to a related party with respect to brand usage or royalty shall be considered material if the transaction(s) to be entered into individually or taken together with previous transactions during a financial</p>

<u>Disclosure</u>	<ol style="list-style-type: none"> 1. Details of contract(s) or arrangement(s) have to be disclosed in the Board's Report along with the justification as per Form AOC-2. (Place the said form before Audit Committee for its review and then to the Board as part of Directors' report for approval) 2. Company shall keep a register in Form MBP - 4 [Pursuant to Section 189(1) and rule 16(1)] giving the particulars of all such contracts or arrangements in such manner and containing particulars as may be required under Section 189 and Rules made thereunder. Details of all related party transactions to be disclosed for the half year, to the stock exchange(s) on the date of publication of its standalone and consolidated financial results and also publish the same on its website. 6. The Company shall disclose the policy on dealing with Related Party Transactions on its website and also in the annual Report.
<u>Records relating to Related Party/ Supporting documents</u>	All disclosures, documents, supporting etc., shall be preserved for a period of eight years from the end of the financial year to which it relates and shall be kept in the custody of the Secretary of the Company or any other person authorized by the Board for the purpose.
<u>(a) Rent Agreement</u>	<ol style="list-style-type: none"> (i) Copy of draft agreement. (ii) Quotation from a property dealer/ advisor in the area in which the property is located or a nearby area. (iii) If quoted prices are substantially lower / higher than existing, to seek second quotation.
