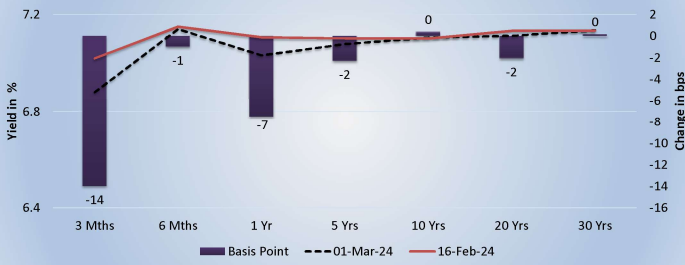

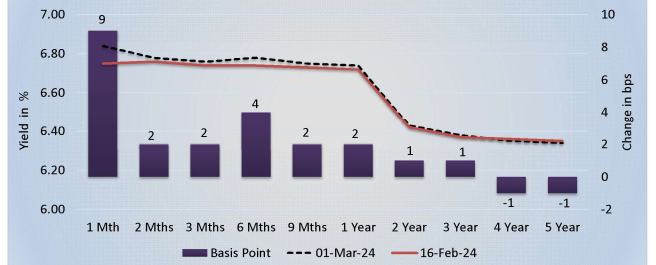

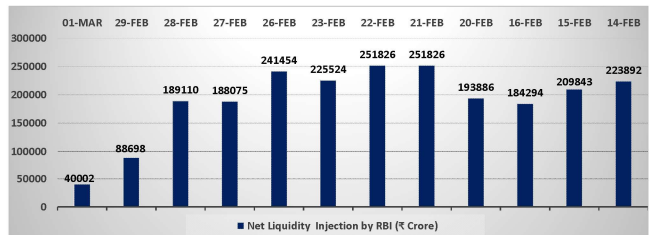

TOTAL MARKET VOLUME



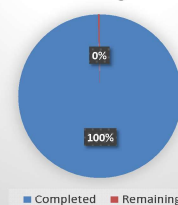
