Sealed Bids on item rate basis are invited for above mentioned work OF OFFICE AT 2ND FLOOR OF PRAGATI TOWER, BKC, MUMBAI 400051

 Prequalification of Contractors: Contractors who are desirous of tendering for above work and fulfill the following requirements shall be eligible to apply. For above work project, Average Annual financial turnover of the firm during the last 3 years, ending <u>31<sup>st</sup> March, 2023</u>, should be at least <u>Rs.50,00,000/-</u> supported with audited balance sheets. Experience of having successfully completed similar\* jobs i.e. last - 7 years (as on 31.03.2023), should be either of the following: One similar\* project of Rs. 50,00,000/- OR Two similar\* projects of Rs. 30,00,000/- OR Three similar\* projects of Rs. 20,00,000/- Details of similar projects and particulars of the contractor to be submitted in prescribed format enclosed under Appendix B.

Undertaking form the bidder that bidder has not been debarred by any public sector organization for violating any act, any such bidder is ineligible to bid during the debarment period.

#### 2. SUBMISSION OF TENDERS

- 2.1 The Bids are to be submitted in three separate envelopes each sealed and clearly super scribed as to envelope number and contents as indicated below. All the three envelopes shall be contained in a large envelope superscribed Furnishing work OF OFFICE AT 2ND FLOOR OF PRAGATI TOWER, BKC, MUMBAI 400051. Bidders have been provided one set of tender documents comprising of general items & conditions Part-A, (for Envelope No.2) and schedule of quantities, Part-B (for Envelope No.3) for submission of their tender.
- 2.2 Bidders must ensure that before submitting their tender that the tender document including corrigendum (if any) has been duly signed and stamped on each page as per instructions.

#### 2.3 ENVELOPE NO.1

Bidder must ensure signature and stamp on all pages and on all cutting/overwriting. Unsigned or incomplete bids will be rejected out rightly.

#### 2.5 **ENVELOPE NO.3**

Envelope No.3 shall contain only Schedule of Quantities (Part 'B') and prices duly filled in and signed on each page by the tenderer . This envelope shall be super scribed "Envelope No.3, Price bid for the work of "Furnishing work OF OFFICE AT 2ND FLOOR OF PRAGATI TOWER, BKC, MUMBAI 400051". Bidder must ensure signature and stamp on all pages and on all cutting/overwriting. Unsigned or incomplete bids will be rejected out rightly.

 Sealed Bids as above will be received in the office of the Exec. Vice President, PNB GILTS LTD, PNB House,4th Floor, Sir PM Road, Fort, Mumbai – 400001, up to <u>15:00</u> <u>Hrs. on 05.12.2023</u>. Envelope No.1, 2 & 3 will be opened on the same day at 15:30 Hrs.

- 4. Bids received late on account of any reason whatsoever and telegraphic bids shall not be entertained in any case whatsoever.
- 5. Earnest Money Deposit (EMD) of Rs.1,04,000/- (Rupees One Lac four thousand only) by crossed Demand Draft/ Pay Order from scheduled commercial bank, payable at <u>Mumbai</u> and drawn in favour of PNB GILTS LTD. (Hereinafter referred to as "PNB GILTS LTD. "which expression shall be deemed to mean and include its successor, administrators and assigns) of the one part &

WHEREAS PNB GILTS LTD. is desirous of executing work of **Furnishing work OF OFFICE AT 2ND FLOOR OF PRAGATI TOWER, BKC, MUMBAI 400051** and has by letter of acceptance dated......accepted a tender by the Contractor for the execution, completion & maintenance of such work. After discussion, PNB GILTS LTD. and the bidder agree to enter into this agreement on the terms and condition set out hereunder:

#### NOW THIS AGREEMENT WITNESSES AS FOLLOWS:

- 1. In this agreement words and expressions shall have the same meaning as are respectively assigned to them in the said conditions of contract hereinafter referred to:
- 2. The following documents, terms and conditions contained therein shall form and construe as integral part and parcel of this agreement and be read as part and parcel of this agreement, viz.
  - a. Original tender document duly signed and stamped on each page by the authorized signatory of the bidder;
  - b. Relevant correspondence letters / communications forming parts of contract and referred to in acceptance letter;
  - c. Acceptance of Award of Work;
  - d. Bill of quantities;
  - e. Corrigendum/Addendums (if published); and
  - f. Other additional documents as may be required.
- 3. The aforesaid documents shall be taken as complementary and mutually explanatory of one another, but in the case of ambiguities of discrepancies the latest documents issued by PNB GILTS LTD. shall prevail over the earlier documents.
- 4. In consideration of payment to be made by PNB GILTS LTD. to the successful bidder as hereinafter mentioned, the successful bidder hereby covenants with PNB GILTS LTD. to perform execute, complete and maintain the work in due respects and in conformity with the provision of the agreement and tender documents.
- 5. PNB GILTS LTD. hereby covenants to pay the Contractor in consideration of the execution, completion of the work such sums as shall become payable hereunder at the time(s) and in the manner prescribed in the said agreement and price schedule of quantities / bill of quantities prescribed in the agreement, subject to the fulfilment of the terms of the agreement by the Contractor.

6. All disputes or differences whatsoever arising between the parties shall be settled amicably. If parties are not able to solve amicably, the same shall be settled by arbitration by a sole arbitrator to be nominated by the competent authority of PNB GILTS LTD. in accordance with Arbitration and Conciliation Act, 1996 and the subsequent rules and regulations framed thereunder, as may be amended from time to time. The award made in pursuance thereof shall be binding on the parties. Venue of arbitration shall be at Delhi and the language shall be English. The Parties to the arbitration shall bear their own costs. The Arbitrator shall give a reasoned award.

The Retention amount will be refunded within 30 (thirty) days after end of the defect liability period, provided that contractor has satisfactorily carried out all the works attended to all defects in accordance with the conditions of the Contract, including the site clearance.

After completion of work, retention money can be refunded after obtaining a Bank Guarantee of equivalent amount for a time period till the end of defect liability period plus claim period. Bank Guarantee should be from any Scheduled Commercial Bank other than PNB GILTS LTD. Claim period would be considered as mentioned on Bank Guarantee or 3 (three) months after the end of defect liability whichever is later.

#### **SECTION - 5 GENERAL CONDITIONS**

- Sealed bids shall be addressed to Exec. Vice President, PNB GILTS LTD, PNB House,4th Floor, Sir PM Road, Fort, Mumbai – 400001 and super scribed Furnishing work OF OFFICE AT 2ND FLOOR OF PRAGATI TOWER, BKC, MUMBAI 400051 and should reach PNB GILTS LTD. before <u>15:00Hrs on 05.12.2023</u> positively.
- 2. No bids shall be received after <u>15:00Hrs on 05.12.2023</u> and the tenders shall be opened on the same day at **15:30Hrs** unless otherwise informed.
- 3. The bids will remain valid for a **period of 90 (ninety) days** from the date of opening of Commercial Bids. PNB GILTS LTD. reserves the right to accept or reject any or all the tenders without assigning any reason what so ever.
- 4. At the time of submission, every bid must be accompanied by:
  - a. Earnest Money Deposit of <u>Rs.</u> 1,04,000/- (Rupees One Lac four thousand only) by crossed Demand Draft/ Pay Order from scheduled commercial bank, payable at **Mumbai** and drawn in favour of PNB GILTS LTD..
  - b. Duly signed and stamped copy of all pages of tender document.
- 5. The bidder shall quote the rates in figures as well as in words. In case of any discrepancy, rate quoted in words will prevail.
- 6. All erasures and alterations made while filling the tender must be attested by initials of tenderer. Overwriting of the figures is not permitted.
- 7. PNB GILTS LTD. reserves the right to reject any or all the tenders, accept part of any tender or entrust the entire work to any other contractor or divide the work to more than one contractor (item wise) without assigning any reason or giving any explanation. The rates quoted by the contractor will hold good for this bifurcation and no compensation will be paid on this account.
- 8. Joint tenders shall not be considered.
- 9. On receipt of information from PNB GILTS LTD. on the acceptance of his tender, the tenderer within 7 (seven) days should submit his acceptance of the work order. If the successful bidder fails to undertake the work, the EMD deposited by him will be forfeited and acceptance of his bid may be withdrawn.
- 10. The rates quoted in the tender shall include all charges of scaffolding, lift for all height, any tools and plants, freight, labour, conditions and fluctuation in the rates, all taxes or expenditure for carrying out the work.
- 11. Electricity & Water shall not be provided by PNB GILTS LTD. to Contractor. Further necessary arrangement/extension, if required, shall be done by the contractor at his own cost with the approval of PNB GILTS LTD..
- 12. No escalation in rates will be allowed under any circumstances.
- 13. The successful bidder is bound to carry out entire work within the period stipulated in the Appendix. The tenderer will have to pay liquidated damages for non-completion of job within stipulated period at 0.5% of the contract amount shown in the tender per week( or part thereof) subject to the ceiling of 10% of the accepted contracted sum (respectively for completion period up to 6 months beyond 6 months company possesses the prerogative to engage with alternative bidders and terminate the existing contract. .).

- 14. The liquidated damages as mentioned above may not be enforced if the contractor applies for extension of time mentioning the reasons for extension. Extension of time in days may be granted by PNB GILTS LTD. at its own discretion if it is proved that contractor is not at fault for extending the work beyond stipulated date of completion.
- 15. The successful bidder is bound to carry out items of work necessary for completion of job even though the same are not included in the schedule of quantity. Rates of extra items shall be derived from the tender. In case the rates do not exist in the tender and extra item is not similar to tender item, then the rates shall be worked out on the prevailing market cost of material sustained by purchase vouchers / bill and labour including wastage plus 15% towards contractor's profit and overhead plus GST as applicable.
- 16. The contractor must co-operate with other contractors appointed by PNB GILTS LTD. so that entire work proceeds smoothly and to the satisfaction of PNB GILTS LTD.
- 17. The contractor shall remove all marks & stains etc. wash and clean the floors at his own cost and hand over the site in proper manner on the completion of work.
- 18. The contractor shall acquaint himself with the site conditions, making his own arrangement for storing of material at site, lift cartage etc.
- 21. Eight percent of the value of work done shall be deducted as security deposit from the running bills of the contractor and will be retained for defects liability period (as mentioned in the Appendix) and shall be released after the defects liability period, provided no defects are noticed during the period.
- 22. The contractor shall attend to all defects noticed during defect liability period. If the contractor fails to attend the defects, these defects will be rectified by PNB GILTS LTD. and the expenditure incurred on this account shall be recovered from their security deposit.
- 23. The contractor shall make adequate arrangement for watch and ward of his material and shall ensure the safety, breakage and any theft of material fixed or unfixed by him or sub-contractors.
- 24. The work executed should be got approved by PNB GILTS LTD. and the contractor shall rectify any bad workmanship pointed out at any stage and remove from site all the rejected materials, immediately.
- 25. The contractor shall be responsible for implementing all the applicable labour laws as may be amended from time to time, compensation for injury and accident to person whether employed by him or by his sub-contractor.
- 26. The contractor shall take necessary precautions for carrying out the work avoiding any damage to structures/decorative parts of the property. The contractor shall rectify any damages thereon at its cost.
- 27. The contractor shall ensure that workmen employed by him for execution of work are suitably covered against Workman's Compensation Act and that all liabilities arising out of Workman's Compensation Act, ESIC and other legislative enactments applicable to such works and workmen shall be to the contractor's account. PNB GILTS LTD. shall not be liable for any compensation to be paid to the workmen by the Contractor in any manner whatsoever.
- 28. The works shall be carried out as per drawings/specifications and to the entire satisfaction of PNB GILTS LTD. or its authorized representatives.

- 29. The contractor shall give due notice to PNB GILTS LTD. to check measurements of any work, which is likely to be hidden before covering the same.
- 30. The contractor shall submit running bills for the value of work done not less than interim payment (as mentioned in the Appendix) mentioning full nomenclatures of items, rates, amount, measurement sheets, reasons for part rates claimed, if any.
- 31. In case of non-completion or delay in completion of work or non-removal of defects in time, PNB GILTS LTD. shall be free to appoint another agency to get the job done at contractor's risk and cost.
- 32. Income Tax as applicable will be deducted at source from the Contractor's bill and will be deposited with the ITO as per rules.
- 33. PNB GILTS LTD. may delay the progress of work, without in any way, vitiating the contract and grant such extension of time for the commencement/completion of the contract as it may think proper and sufficient in consequence of such delay and the contractor shall not make claim for compensation or damage in relation thereto.
- 34. The contractor shall not execute any extra item without PNB GILTS LTD.'s permission in writing.
- 35. The quantities mentioned in the schedule of quantities are approximate and can vary up to any extent. Payment shall be made on actual work done by the contractor. However, the contractor should not deviate the quantity without PNB GILTS LTD.'s permission.
- 36. Conditional tender quoted by the bidder is liable to be rejected.
- 37. PNB GILTS LTD. has a right to alter the nature of work and to add or omit any item of work or to have the opinion of the same carried out departmentally or otherwise and such alternation of variations shall be carried out without prejudice to this contract.
- 38. PNB GILTS LTD. has right to terminate the contract, if the contractor abandons the work or fails to commence and complete the work in time or fails to abide by the contract conditions.

Deviation in Tender Quantities: -

- 39. The bid rate shall hold good for any increase in the tender quantities upto the variation of 25%. In case tender quantities of an individual item exceeds the deviation limit of 25%, the rates for the excess quantities over and above the deviation limit then the rates will be worked out on the prevailing market cost of material sustained by purchase vouchers / bills and labour including wastage plus 15% towards Contractor's profit and overheads.
- 40. Substitution: Should the contractor desire to substitute any materials and workmanship, he/they must obtain the approval of PNB GILTS LTD. in writing for any such substitution well in advance. Materials designated in the specification identified by such Term as "Equal" or "Other approved" etc. specific approval of PNB GILTS LTD./Architects to be obtained in writing.
- 41. Concealed Work :- The contractor shall give due notice to PNB GILTS LTD. whenever any work is to be buried in the earth, concrete or concealed or otherwise, becoming inaccessible later on, in order that the work may be inspected and correct dimensions taken before such burial, in default whereof the same shall, at the opinion of PNB GILTS LTD. be either opened up for measurement at the contractor's expense or no payment may be made for such materials, should any dispute or difference arise after the execution of any work as to measurements etc. or other matters which cannot be conveniently tested or

checked, the notes of PNB GILTS LTD. shall be accepted as correct and binding on the Contractor.

42. The successful bidder is bound to carry out items of work necessary for completion of job even though the same are not included in the Schedule of Quantities. Rates of extra items will be derived from the tender. In case the rates do not exist in the tender and extra item is not similar to tender item, then the rates will be worked out on the prevailing market cost of material sub stained by purchase vouchers and labour including wastage Plus 15% towards Contractor's profit and overheads.

Advance Payment and Secured Advance: -

- 43. Advance payment for works actually executed but not measured and billed for, should not be made generally. Payment should only be made after the detailed measurements of the work are taken and recorded and the contractor's bill for the same is approved by the Competent Authority of PNB GILTS LTD.
- 44. However, advance payments on the running bills to the extent of 75% of PNB GILTS LTD.s' engineers certified amount may be made wherever found necessary. In such cases, it shall be ensured that the test checking of the measurements & scrutiny of bills are completed before payment of the next running bill.

45. Secured advance against the security of materials brought to site may be made to the contractors whose contract is for finished work. In such cases, the Competent Authority may sanction advances upto an amount not exceeding 75% of the value (invoiced/assessed value) of such materials, provided that they are of a durable/nonfragile nature and that an Indemnity Bond is drawn up with the, contractor under which PNB GILTS LTD. secures a lien on the materials and is safeguarded against loses due to the contractor postponing the execution of work or to the shortage or misuse of the materials, and against the expense entailed, if any, for their proper watch and safe custody. Recoveries of advances so made should not be postponed until the whole of the work entrusted to the contractor is completed. They should be made from his bills for works done as the materials are used, the necessary deductions being made whenever the item of work in which they are used are billed for. In all cases, the repayment of the advance will be affected after expiry of a period of 120 days since payment of advance, whether the material is consumed in the work or not.

46. Disputes and Arbitration: All disputes or differences, whatsoever, arising between the parties out of or in relation to the terms and conditions, meaning and operation or effect of this Agreement or breach thereof shall be settled amicably.

In case they are not able to settle the disputes or differences between them amicably, the matter may be referred to a sole arbitrator to be appointed by PNB GILTS LTD. after issue of at least 30 day notice in writing to the other party clearly setting out there in the specific disputes and the same shall be settled by arbitration in accordance with the Indian Laws relating to arbitration, i.e. in accordance with the provision of the Indian Arbitration and Conciliation Act, 1996 and Rules and Regulations framed thereunder and the award made in pursuance thereof shall be binding on the parties. Parties to the arbitration shall bear their own costs.

The venue of arbitration shall be **Delhi**.

All arbitration proceeding shall be conducted in English and a daily English record of such proceeding shall be maintained.

Any appeal against the arbitration award will be subject to the jurisdiction of courts at **Delhi** only.

Successful Bidder/Contractor shall continue to work under the work Contract during the arbitration proceedings unless otherwise directed in writing by PNB GILTS LTD., unless the matter is such that the works/services cannot possibly be continued until the decision of the arbitrator or of the presiding arbitrator, as the case may be, is obtained.

#### SPECIAL CONDITIONS OF CONTRACT

- Intending contractor shall visit the site and get acquainted with site conditions and activities during the working hours before quoting the rates. The contractor should note and bear in mind that PNB GILTS LTD. shall bear no responsibility for the lack of acquaintance of site and other conditions or any information relating thereto or on its part.
- 2. All measurements shall be made as per CPWD norms. If for any item of work specification are not available in tender documents, latest CPWD specifications shall be followed.
- 3. Site should be cleaned every day and all the unusable material/malba shall be removed from the site and unusable materials shall be stacked properly so that there is no hindrance for staff and public failing which PNB GILTS LTD. will remove the same at their level and reasonable amount as considered appropriate by PNB GILTS LTD. shall be recovered from the contractor's bill.
- 4. The work should be carried out as per latest CPWD specification and as per the standard engineering practice.
- 5. The contractor shall take all necessary precautions for carrying out the work avoiding any damage to the structure, marble flooring of staircase and paint on the wall etc. before and during execution of job. The contractor shall submit an undertaking in this regard with each bill confirming payment of all dues of subcontractors and all statutory wages to labour working under him/her/subcontractor.

- 14. The Contractor will be responsible to fulfil all the obligations in connection with the workers employed by the Contractor for the purpose of the Contract and all the Statutory and other liabilities, if any, including minimum wages, leave salary, uniform, ex-gratia, gratuity, ESI, Provident Fund, Workman Compensation, if any, etc. in connection therewith shall be on the Contractor's accountant payable by the Contractor. The Contractor shall have no claims whatsoever against PNB GILTS LTD. with respect to payment of statutory dues/contributions to his personnel/employees under applicable labour legislations.
- 15. The employees/workers engaged by the contractor shall be deemed to be the employees of contractor only, and PNB GILTS LTD. shall not be connected with the employment or the terms and conditions thereof in any way. The contractor alone would comply with the statutory obligations and labour regulations/ rules in this regard. None of the provisions of this agreement shall be deemed to constitute a partnership or joint venture or employee- employee relationship between the parties hereto, and neither party shall have authority to bind the other except as specifically provided for hereunder. Neither party hereto is the agent of the other nor there is a master –servant relationship between the parties. The relationship is on principal to principal basis.
- 16. Contractor should obtain necessary permission that may be required for the purpose of this contract from such authorities as may be prescribed by the applicable laws from time to time.
- 17. Contractor or his authorized representative should visit the site frequently as required by PNB GILTS LTD. and meet PNB GILTS LTD.'s engineer with prior appointment for any clarifications and to receive instructions, take measurements, etc. at the site.
- 18. Contractor shall be fully responsible and shall compensate PNB GILTS LTD. with suitable insurance cover in the event of any damage to men or material, injury / damage or death as the case may be, caused directly or indirectly due to the negligence of the Contractor or his agents and / or his employees or workmen. The decision of PNB GILTS LTD. in this regard shall be final and binding.
- 19. 
